Visu Sewer has completed their project to clean and televise the storm sewer on Oak Street. Jamie Van Beek will review the video again. There are areas of the storm sewer that may need to be replaced and/or repaired.

Marv Arp met with Council Members concerning the drainage of storm water on Douglas Street and Rebecca Lane. Marv had several pictures of the drainage and discussed areas of concern. Storm sewer mains should be included with any new development.

Cody Ver Steeg, Brian Blankespoor, Willy Wiekamp, and Jon Wiekamp met with Council members about the tractor pull that was held in Inwood on June 7. The Tractor Pull was a great success. There were more than 600 people attending and there were 123 hooks. The group discussed updating the ball park lights.
